## GDPR - General Data Protection Regulation

## How we use your data:

- We use your **Name and Address** to create a mailing list and send you a Free magazine bi-monthly. We may also use your address to determine geographical data for Events and Local Groups.
- We may use your **Telephone number** to contact you in exceptional circumstances, ie: Event Cancellations or an Emergency, or for unpaid subscriptions.
- We may use your **Email Address** to contact you electronically, using an electronic mailing list, to distribute bulk notifications.
- We may hold your **Sunbeam car details** in the Club Register to determine the number of surviving cars and estimate the demand for parts remanufacture, and use them as a basis for determining suitable cars for display on the Clubs behalf at major events.

We will not share your data with Third Parties (except for our Printers to send you a magazine), we will not sell your data to Third Parties.

You have the right to ask Sunbeam Alpine Owners Club Ltd to supply you with a copy of the data held on request. We will charge you £1 to supply you with this information, within 14 days of the request in writing.

You have the right to ask Sunbeam Alpine Owners Club Ltd to remove or delete any of your data we hold at anytime.
